SECTION I: INSTRUCTIONS TO BIDDERS

NB: Section 66(1)(b) of the Public Procurement Act 15 of 2015 will apply. “A staff member of the Board or public entity involved in planning or conducting procurement process or contract administration must undertake – to act in the public interest and in accordance with this Act.”

1. Rights of Public Entity

The Kavango East Regional Council reserves the right:

- (a) To split the contract as per the lowest evaluated cost per item, or
- (b) To accept or reject any quotation or to cancel the quotation process and reject all quotations at any time prior to contract award.

2. Preparation of Quotations

You are requested to quote for the works mentioned in Section III by completing, signing and returning:

- (a) the Quotation Letter in Section II with its annex for Bid Securing Declaration; and
- (b) the Priced Activity Schedule Section IV;
- (c) the Specifications and Compliance Sheet in Section V; and
- (d) any other attachment as deemed appropriate

You are advised to carefully read the complete Request for Sealed Quotations document, including the Special Conditions of Contract in Section VII, before preparing your quotation. The standard forms in this document may be retyped for completion but the Bidder is responsible for their accurate reproduction.

3. Validity of Quotations

The quotation validity period shall be 180 days from the date of bid submission deadline.

4. Eligibility Criteria

To be eligible to participate in this Quotation exercise, you should:

- (a) Have a valid certified copy of Company Registration Certificate;
- (b) Have an original valid or certified copy of Good Standing Tax Certificate;
- (c) Have an original valid or certified copy of Good Standing Social Security Certificate;
- (d) Have a valid certified copy of Good Standing Certificate from BIPA
- (e) Have a valid certified copy of Affirmative Action Compliance Certificate, proof from Employment Equity Commissioner that the bidder is not a relevant employer, or exemption issued in terms of Section 42 of the Affirmative Act, 1998;
- (f) Have a certified copy of SME Certificate
- (g) Submit a signed Bid Securing Declaration
- (h) Attach at least Two (2) Practical Completion Certificate for previous experience in construction
- (i) Business Principle must be in line with this procurement
- (j) Attach Certified Identity Document (s) of the Company Owner (s)

(k) Submit work Program indicating **duration and deliverable**

(l) **Additional requirements**

- (a) Document to be filled completed with black ink
- (b) All pages of the bidding document must be initialled.
- (c) All correction must be initialled.
- (d) No eraser (Tippex) to be used.
- (e) No correction to the original Bill of Quantities is allowed.
- (f) Use of Government envelop will lead to disqualification.
- (g) Submit complete signed and stamped **Bid-securing Declaration**;

5. Bid Securing Declaration

Bidders are required to subscribe to a Bid Securing Declaration for this procurement process.

6. Works Completion Period

The completion period for works shall be **90 days** after acceptance and issue of Purchase Order. Deviation in completion period shall be considered if such deviation is reasonable.

7. Sealing and Marking of Quotations

Quotations should be sealed in a single envelope, clearly marked with the **Procurement Reference Number**, addressed to **Kavango East Regional Council** with the **Bidder's name** and **contact information** at the back of the envelope.

8. Submission of Quotations

Quotations should be deposited in the Quotation/ Bid Box located at **Kavango East Regional Council, Maria Mwengere Street, Rundu, at Office number 11**. Not later than **19 March 2026 at 11h00am**. Late quotation will be rejected.

9. Opening of Quotations

Quotations will be opened internally by the Public Entity after the closing time referred to in instruction 8 above. A record of the Quotation Opening stating the name of the bidders, the amount quoted, the presence or absence of a Bid Securing Declaration, will be posted on the website of the Kavango East Regional Council.

10. Evaluation of Quotations

The Public Entity shall have the right to request for clarifications in writing during evaluation. Offers that are substantially responsive shall be compared on the basis of price or ownership cost, subject to Margin of Preference where applicable, to determine the lowest evaluated quotation.

11. Technical Compliance

The Specifications and Compliance Sheet details the minimum specifications of the works to be carried out. The specifications have to be met, but no credit will be given for exceeding the specifications.

12. Prices and Currency of Payment

Prices shall be fixed in Namibian Dollars. Quotations shall cover all costs of labour, materials, equipment, overheads, profits, and all associated costs for performing the works, and shall include all duties. The whole cost of performing the works shall be in the items stated, and the cost of any incidental works shall be deemed to be included in the prices quoted.

13. Margin of Preference

Bidders Preference will be given to bidders whose total bid price falls within $\pm 5\%$ of the budgeted cost estimate.

14. Award of Contract

The Bidder having submitted the lowest evaluated responsive quotation and qualified to perform the works shall be selected for award of contract. Award of contract shall be by issue of a *Purchase Order/Letter of Acceptance* in accordance with terms and conditions contained in *Section VI: Contract Agreement and General Conditions of Contract*.

15. Notification of Award and Debriefing

The Public Entity shall after award of contract promptly inform all unsuccessful bidders in writing of the name and address of the successful bidder and the contract amount and post a notice of award on its website within 7 days. Furthermore, the Public Entity shall attend to all requests for debriefing made in writing within 7 days of the unsuccessful bidders being informed of the award.

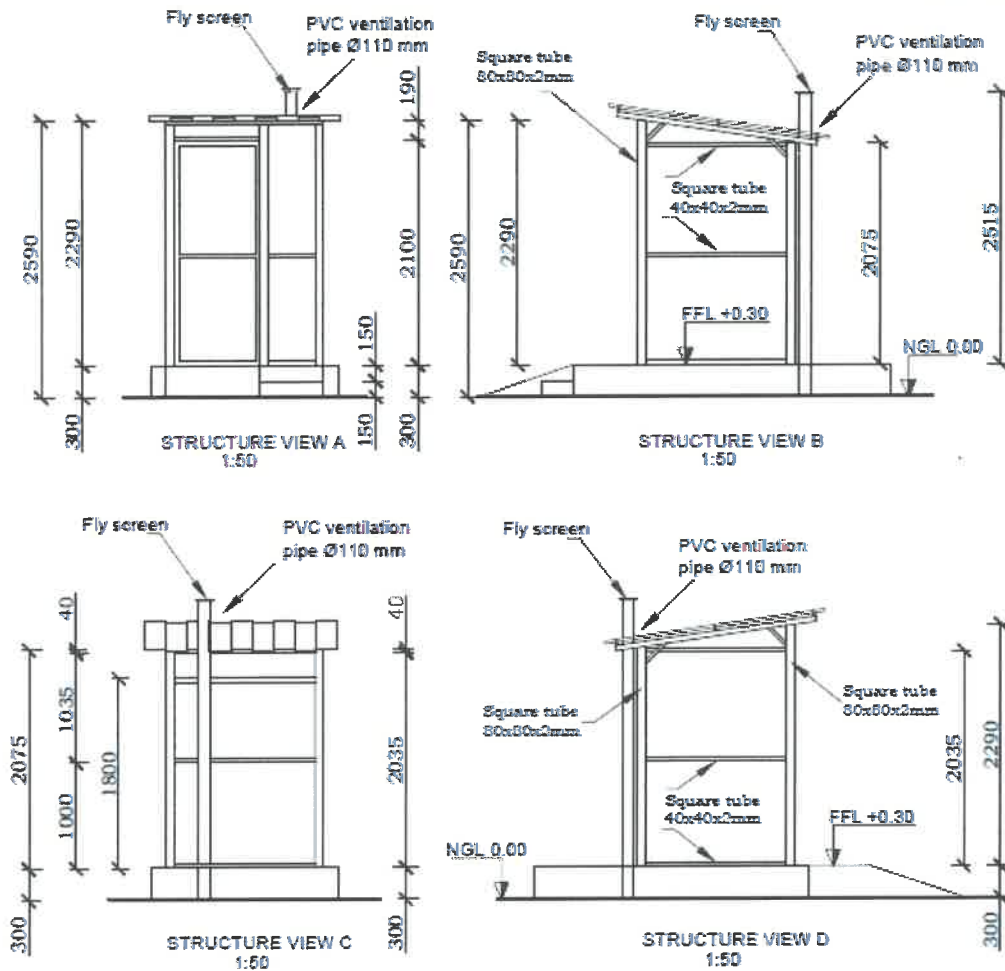

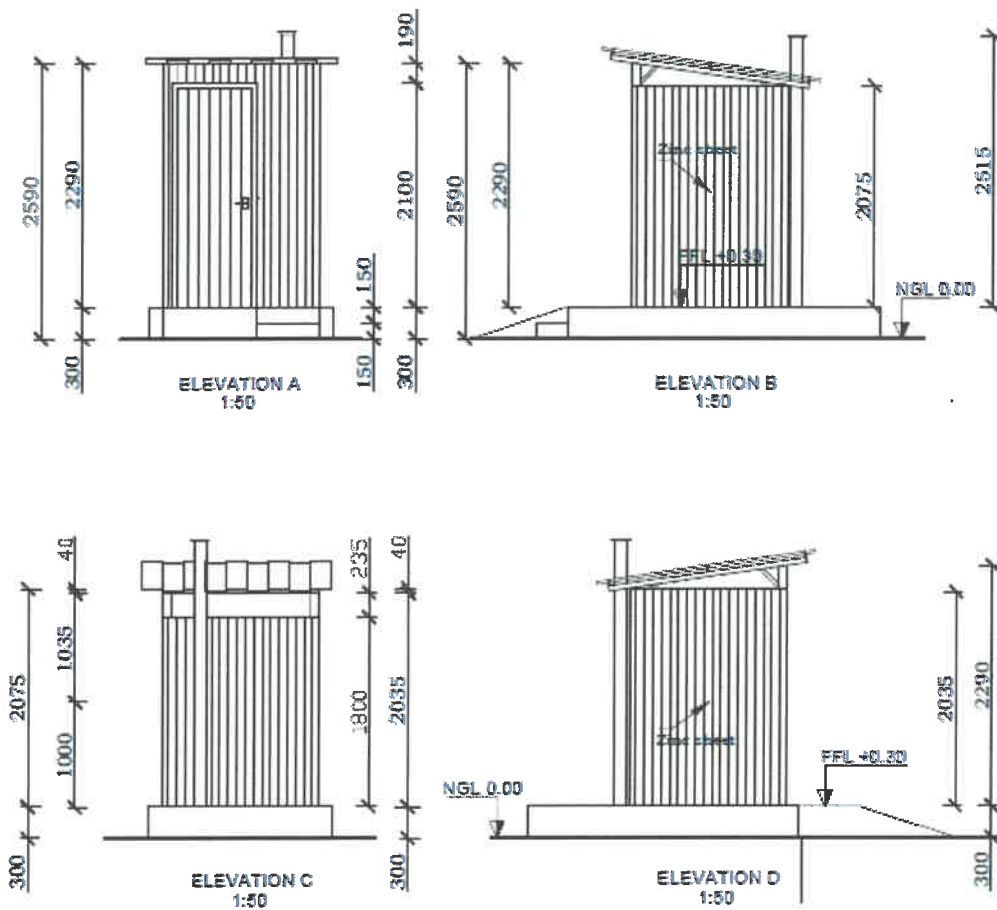

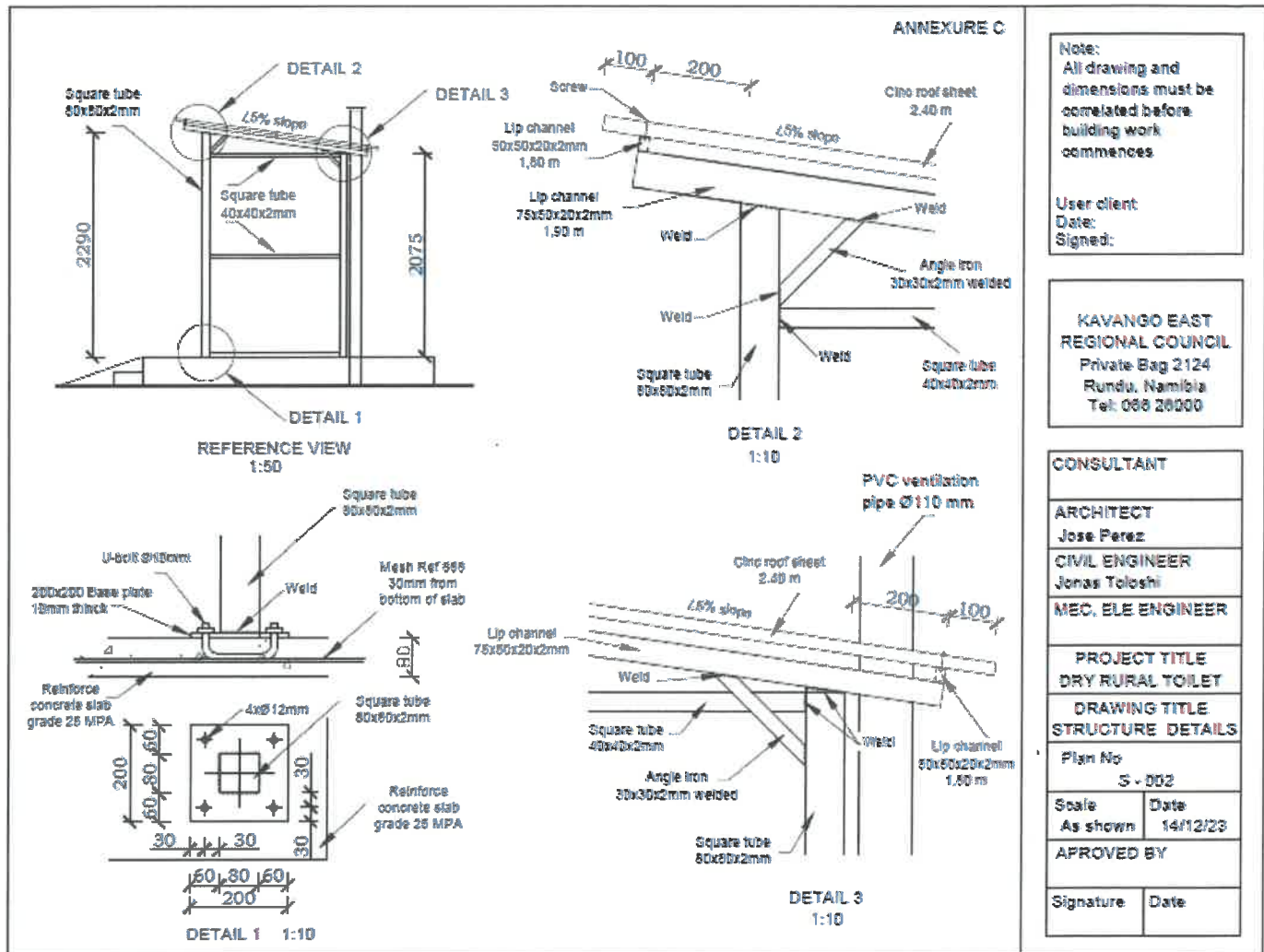
